¹ This letter by Steven Orlow, President of the Yesha Council's One Israel Fund, was written in response to the following article by David Bedein (February 11, 2000):

“During the years of my coverage of the Oslo process, I have tried to present facts and analysis that would be free of tendentiousness and ad-homonym attacks. There are times, however, that we must describe a phenomenon for what it is.

“On February 10, 2000, the Yesha Council met with Minister of Justice Yossi Beilin and gave its tacit approval to the approach which Beilin has advocated since the first day of the Oslo process: which is that some Jews would have to live under the authority of the PLO.

“This is not a new approach. Beilin, when he was deputy foreign minister, told me and other reporters in a recorded interview on December 8, 1993, that all Jews may remain in their settlements, even though they will have to live under PLO rule.

“Yet it so happens that on October 21, 1993, the PLO declared that any Jew who lives in these settlements is a candidate for murder. That “rule” was declared after Haim Mizrachi was burned to death just outside of Beit El.

“Since that murder, every murder of Jews in Yesha has been endorsed and approved by the official PA media.

“In other words, living under PLO rule means living in a death camp, by definition.

“Any organization that agrees to the idea of any Jew living under PLO rule has therefore sentenced that Jew to death.

“The Yesha Council has sentenced Jews to death, under the formula that Yossi Beilin has articulated.

“Should the city of Efrat continue to support funds for the Yesha Council under such circumstance?

“Should the YESHA COUNCIL in Jerusalem and the ONE ISRAEL FUND in NYC be held responsible for this death sentence for Jews?

CANVASS OF SECURITY ASSISTANCE TO YESHA

77% of the Yeshans polled for this study said they think the Yesha Council's performance warrants more oversight. The Nachaliel Office for Yesha is publicizing the yishuv-by-yishuv canvass concerning the Yesha Council's deliveries of equipment and overall performance as a service to them in their desire for additional scrutiny, and to assist donors to Yesha in improving the effectiveness of their financial support.

In the canvass, three questions were posed to yishuv secretaries and/or security officers concerning the current war situation:

- **Q1:** We are doing a check for donors in the Diaspora who were requested by the Yesha Council to give money towards equipment for yishuvim. I'm checking who has received equipment and who hasn't. We're talking about generators, medical rescue equipment, binoculars, night vision equipment, telescopes, etc. Has your community received any equipment or promises of equipment from Moetzet Yesha?
- **Q2:** How do you rate the Yesha Council's performance in supplying your yishuv for the war situation, satisfactory or unsatisfactory?
- **Q3:** Do you feel that the Yesha Council's performance warrants more oversight by Yesha residents?

123 out of 142 communities responded to the poll, an 86.6% response rate. Of those, 118 out of the 123 (96%) reported no aid whatsoever from the Yesha Council.

94% of Yesha communities found Moetzet Yesha's performance in getting aid to the embattled communities unsatisfactory. 77% desire more oversight of the Yesha Council.

WRITTEN DURING AND IMMEDIATELY AFTER CANVASS*:

One element of the Yesha Council's appeal is the skill with which they concoct information to pander to the fantasies and wishful thinking of the "Right". They ceaselessly promoted a glowing vision of the IDF's leadership under which an expulsion or first strike eviction would be unthinkable. Perhaps this helped foster the illusion for Yeshans that someone inside the government is still on their side and gives them a hope to cling to and thus maintain their comfortable inaction and paralysis.

The suffering of the yishuvim concerning their lack of rudimentary security equipment shows the serious cost of the Yesha Council's and One Israel Fund's claim to be the only authorized distribution and delivery middleman for material assistance. There are already at least 25 competing Yesha fundraising, delivery, and distribution services, but a window of vulnerability to a violent eviction will always remain as long as Yesha's leaders withhold from yishuv residents a set of authoritative, practical steps to deter or defeat an expulsion.

Someone may be paying the Yesha Council to forestall a new Jewish "Right" that is disciplined in discerning the facts.

Facts on which Israel's survival depend and urgently await our exposure.

The Yesha Council's open damage control letter, attempting to rebut this author’s findings, and other previous mailings did not contain the line about being authorized (by whom?) to raise funds. However, after the Nachaliel Office for Yesha released its *Report on the Acquiescence of the Israeli Government in Palestinian Authority First Strike Preparations in Yesha*, the following began to appear at the end of a Yesha Council correspondence beginning on June 17, 1999: “Aharon Domb is Director General of the YESHA Council, representatives of the 144 communities and nearly 200,000 Jewish residents of Judea, Samaria and Gaza. The One Israel Fund/Yesha is the only organization in the U.S. authorized to raise funds on behalf of the Jewish communities of these regions.”

After actually departing the Yesha Council, Domb received the job of Director General of the Israel Ministry of Tourism. He was later served a multi-count indictment including extortion, threatening a witness, and fraud, pertaining to a non-profit organization that was in his charge during the years 1996-1999, the “Yesha Tourism Fund” (Arutz-7, December 28, 2004).

COMMENTS MADE BY YISHUV OFFICIALS

WHEN ASKED ABOUT YESHA COUNCIL SUPPORT:

We were able to contact fourteen yishuvim from the One Israel Fund's list, and we found that even those few who did receive donations were still misrepresented on the One Israel Fund's website. Elon Moreh, for instance, who say they did get a \$10,000 subsidy for a security vehicle, and were PROMISED that a bullet proof ambulance would arrive in six months(!) - though the site claims they already received one. They never got any other security equipment, and the monitor defibrillator they have didn't come from the Yesha Council (as boasted on their website), but from private donors close to Elon Moreh.

- **Itamar**: Ravshatz, Shlomo Miller (cellphone 057-760-370). "I'm very interested to speak with the donors from chu"l - we have a 'full belly' on the Yesha Council. I don't know what this One Israel Fund organization is. We sent a man to fundraise in chu"l and he was confronted there with arguments from someone who apparently is from One Israel Fund who got angry at us: 'What are you people doing - you received! - What didn't you receive!?!...'"
- **Ma'aleh Michmash**: Uriel ben-Sa'adon, 058-289-919. "Whatever we have, we didn't receive from the Yesha Council, but from private organizations."
- **Alon Moreh**: Ravshatz Chaim Ya'akobi 064-615-531. "We got \$10,000 subsidy for a security vehicle [According to Israel Danziger, this subsidy came from the army, Pikud HaOref, not Yesha Council]. We are supposed to receive within a half a year a bulletproof ambulance from One Israel Fund. We didn't receive other security equipment. Our monitor was not received from Yesha Council but from private donors close to Alon Moreh."
- **Sha'arei Tikvah**: Ravshatz Avichai, 057-723-765. He got equipment but as far as he knows it came from Pikud HaOref (army) and not Yesha Council.
- **Kedumim**: Security Officer of the Moatza Shlomi Chazoni, 057-756-488. "I know there are things not *beseder* with the Yesha Council, so I'm speaking very carefully.."
- **Rimonim**: Secretary Michal. Received nothing from Yesha Council and are in need of security equipment. She also was not aware that the Yesha Council was fundraising using their name in chu"l.
- **Gadid**: "We received nothing from the Yesha Council except dolls for children, like all the yishuvim around here."
- **Avnei Chefetz**: Ravshatz Uriel Senderfen, 054-711-841: "We never got anything from the Yesha Council."
- **Netzer Chazani**: Ravshatz Yoram Tzror, 055-684-975. "Received equipment from Yesha Council shortly after start of current intifada two years ago. No new equipment in past year."
- **Adura**: Ravshatz Lior Duchan 058-993-258. Didn't receive equipment from Yesha Council.
- **Morag**: Ravshatz Nachshon Challili, 055-236-424. "We received nothing."
- **Enav**: Secretary of yishuv, received no equipment.

Additionally, whoever created the One Israel Fund web page is obviously ignorant of Yesha's geography and population. In their "security projects" list on the "What Your Dollars Have Done" page:

- Apparently, no-one in One Israel Fund knows that "Gush Katif" is a Gush, so they list them as a separate community who receives One Israel's beneficence - but this does not stop them from also listing yishuvim IN Gush Katif itself in the same list: Gadid and Morag (who have to get back to us) and Netzer Chazani (who say they received when the war began but absolutely nothing in the past year).
- They have one yishuv listed twice, "Bracha" and "Har Bracha";
- They never heard of "Avnei Chefetz" so they spell it "Admei Chefet".

Aruch HaShulchan Choshen Mishpat 426 (the obligation for a man to rescue his neighbor by physical or monetary means)

A. One who sees his neighbor drowning or being attacked by bandits, animals, or any other danger – and is capable of personally rescuing him or hiring others to rescue him, and failed to rescue;

Or, one heard enemies conspiring to harm one's neighbor and he fails to inform that neighbor;

Or if one becomes aware that an oppressor intends to extort one's neighbor, and he is able to pacify the oppressor and fails to do so,

These and all similar circumstances violate the prohibition “Do not stand idly by your brother's blood”.

...And all the more so is one obligated to prevent injury or loss to the many. Therefore if one is aware of someone committing an act that approaches injury or loss to the many, or even to an individual, one is obligated to object if he is able to.

D. The *Poskim* cite the *Yerushalmi* Talmud that one is obligated to expose oneself to possible danger in order to rescue his neighbor. The *Rishonim* omit this because in our Talmud it is proven that one is not obligated to involve oneself. However, each case goes according to its context, and one must weigh the issue honestly and not guard oneself too much. On this it is said, “He who carefully evaluates the consequences of his ways - I will show him the salvation of G-d.” (In *Yesha* – I will show him G-d...) And saving one Jewish life is tantamount to saving an entire universe...
